Subject: REGISTRATION & AFFILIATION RENEWAL NOTICE FOR ALL REGISTERED INSTITUTES UNDER THE NATIONAL TRAINING BUREAU (NTB)/NAVTTC.

With reference to the subject cited above, the competent authority has instructed the announcement of renewal guidelines for all institutes previously registered with the National Training Bureau NTB (defunct)/NAVTTC, whose registrations are due to expire between August 2024 and December 2024. All registered institutes are required to carefully review the instructions and apply for registration renewal according to the newly approved NAVTTC framework.

2. Under the National Training Ordinance-1980, the National Training Bureau (NTB) was responsible for the registration & affiliation of institutes, and managed trade testing and certification of the trainees nationwide. With the repeal of the 1980 ordinance, these functions were transferred to NAVTTC under the NAVTTC Act-2011, amended in 2021. The NAVTTC Board of Management (BoM) established the Registration & Affiliation Section to manage these functions and transformed the Certification Section into the National Trade Testing Board (NTTB), which now handles the functions of the former National Training Bureau. These changes were formalized during the 26th NAVTTC BoM meeting on September 1, 2023, and both sections now operate independently under the A&C wing of NAVTTC HQs.

3. The NAVTTC has revised the registration and affiliation fee as follows, and all institutes previously registered with NTB NAVTTC must apply for registration and affiliation separately: To streamline and verify the authenticity of the institutes, all institutes with registrations expiring from August 2024 to December 2024 are directed to apply for renewal of their registration with the revised fee between August 22nd, 2024, and September 30th, 2024. Following registration renewal, institutes must then apply for the renewal of their affiliation as per the new NAVTTC procedures.

Application Process:

- 1) Apply for renewal of registration at (http://register.navttc.gov.pk).
- 2) Complete the profile and download the application along with the challan form.
- 3) Pay the fee into the "NAVTTC-Fund" at account number "IBAN No: PK40NBPA1732004001509626" at the National Bank of Pakistan, M SECTT Branch, Islamabad.
- 4) Attach all required documents with the downloaded application and the original paid challan form.
- 5) Dispatch the renewal application to the Director (R&A) Section, A&C wing, NAVTTC HQs, Islamabad.

4. Institutes that fail to apply for renewal within the stipulated time will be deemed uninterested and non-existent at the registered location and their registration should be treated as withdrawn/cancelled. Only those institutes that apply for renewal will be processed accordingly.
