National Vocational and Technical Training Commission (NAVTTC), under Ministry of Federal Education and Professional Training is the apex body for technical education and vocational training (TVET) in the country.

In order to uplift and strengthen the **Driving Trades (LTV, HTV & HMO)** of Pakistan, NAVTTC is launching trade-specific intervention.

Following demand-driven trades are being offered for training in Batch-2 of PMYSD: (Not limited to the following, Institutes may propose high-employment trades in the sector.)

NAVTTC invites Expression of Interest (EOI) from technically qualified and financially sound Public/Private Technical & Vocational Training Institutes, universities, small, medium entities, enterprises & Industries to run specialized trainings for LTV/HTV & HMO trades.

The applying institute will submit a registeration fee of Rs. 25,000 and a per trade fee of Rs. 10,000 in the name of NAVTTC account upon award of contract.

Account details will be shared later.

An applicant institute must be registered / affiliated under respective Provincial Technical Education & Vocational Training Authority (TEVTA), Board of Technical Education (BTE), Trade Testing Board (TTB) or a HEC recognized University. An applicant entity, enterprise or industry must be registered under Industrial Act or have the membership with local Chamber of Commerce & Industries and have an Industrial Training Unit to impart skill training. NAVTTC may utilize the selected institutes as assessment centers for its regular interventions like Recognition of Prior Learning (RPL), Competency-Based Training & Assessment (CBT&A), and Takamol as needed.

All applicant institutes/industry are required to create new login and apply for the Specialized LTV/HTV & HMO Trades on NAVTTC's online Project Management System (PMS) link: https://nsis.navttc.gov.pk/institute-signup/hmo-and-driving available from 4th August, 2024 to 19th August, 2024. Hardcopies of filled-in application proforma by all institutes/entities/universities along with supporting documentary evidence must reach at below mentioned concerned Regional Offices of NAVTTC by 11:00 AM of 19th August, 2024. Eol applications will be opened on 11:30 AM of the same date at NAVTTC, Regional Offices located at below mentioned addresses.
