Subject: RECRUITMENT AGIANST THE POST OF BPS 17 TO 19 IN NAVTTC.

Kindly refer to the subject noted above.

- 2. NAVTTC Board in its 25th meeting dated 14-10-2021 has considered the agenda item on the subject mentioned above and decided as under:-
  - "The past exercise initiated last year, in which test or interviews were not conducted, is cancelled
  - ii. The NAVTIC management is encouraged to approach Federal Public Service Commission (FPSC) for the recruitments of NAVTTC above BS-17. The matter will again be placed before the Board and further action will be taken by the Board of Management, after reviewing the response of FPSC."
- 3. In this regard it is to inform that since establishment of NAVTTC, official business of the organization was mostly being run with the services of deputationists and hiring services of contract employees on lump sum salary package due to non existing of service rules.
- NAVTTC Employees (Service) Regulations-2018 have been approved and notified 4. in the Gazette of Pakistan in 2018. Subsequently, NAVTTC has completed the process of recruitment of staff in BPS-01 to 16 and advertised posts in BPS-17 to 19, meant for direct recruitment. But in consideration of lack of capacity in NAVTTC for conducting test/ interview and to ensure transparency, NAVTTC Board has decided cancellation of advertisement and recruitment from BPS-17 and above through Federal Public Service Commission (FPSC).
- It is, therefore, requested that case may kindly be taken up with Federal Public 5. Service Commission (FPSC) for recruitment against posts in BPS-17 to 19 falling under direct recruitment quota in NAVTTC.
