Appointment of Legal Counsel for Pakistan Skills Impact Bond (PSIB)by

National Vocational and Technical Training Commission (NAVTTC), Government of Pakistan

Sealed bids are invited from legal firm duly registered with SECP or Registrar of the Firms and / Income Tax / Sales Tax Departments / relevant authorities and having minimum of 10 years work experience for "Appointment of Legal Counsel for Pakistan Skills Impact Bond (PSIB) by National Vocational and Technical Training Commission (NAVTTC), Government of Pakistan.". The services of the legal firm are being sought for the following:

- NAVTTC, as Pakistan's National Body for technical and vocational training, is launching the Pakistan Skills Impact Bond (PSIB) to address youth unemployment through an outcome-based financing framework.
- Bridge Factor is advising NAVTTC as Financial Advisor while the Bank of Punjab (BOP) and British Asian Trust (BAT) have been appointed as Transaction Advisors & Program Managers (TAPM) for PSIB.
- BOP is appointing its own Lender's Legal Counsel to manage issuance documentation, filings and investor-side protections.
- NAVTTC requires independent Legal Counsel to safeguard its institutional interests, ensure compliance with law and provide authoritative legal opinions.
- 2. **Single Stage two Envelope (Quality and Cost Based)** procedure will be adopted under Rule 36 (b) of PPR Rules-2004. The sealed bids complete in all respects should be submitted through EPADS and also in hard format before the cut-off date.
