INVITATION FOR PREQUALIFICATION APPLICATIONS FROM AUTHORIZED ENERGY SERVICE COMPANIES (ESCOs) FOR SOLARIZATION OF THE NATIONAL VOCATIONAL AND TECHNICAL TRAINING COMMISSION (NAVTTC) HQ AND CENTER OF EXCELLENCE (CoE) OFFICE AT ISLAMABAD

- 1- The National Vocational and Technical Training Commission (NAVTTC) intends to solarize its Premises on an ESCO model and seeks proposals to pre-qualify firms / contractors / companies registered with Income Tax department and Sales Tax Department and who are on Active Taxpayer List of the FBR. Energy Service Companies (ESCOs) will finance/invest, design, supply and installation as well as operation and maintenance (O&M) and up-gradation on turnkey Basis through competitive tariff based bidding process for grid tied solar PV systems up to 200 KW.
- 2- Interested applicant (firms/Companies/JVs/ legal entities) may get the complete set of Pre-qualification Document (PQD) from undersigned on submission of written application on letter head of the company along with the copy of CNIC of authorized person upon a pay order/demand draft of Rs.5000/- (Five thousand Rupees non-refundable) in favour of the Executive Director NAVTTC during office working hours.
- 3- The Prequalification Document can also be downloaded from the NAVTTC website (www.navttc.gov.pk) free of cost.
- 4- Sealed Proposals for Prequalification (Clearly marked as "Application for Prequalification for Solarization with net metering of the NAVTTC") are required to be brought in person, by the authorized-representative or through registered mail of interested applicants on or before 24.07.2023 at 10:30 am in the committee room of NAVTTC, Headquarter. Prequalification applications shall be opened on the same day (24.07.2023) at 11:00 am at Committee Room in presence of the Applicants by the procurement committee concerned of the Commission.
- 5- In case of public holiday, the next official working day shall be considered as the last date.
- 6- Sign and stamp on each page of document and form is mandatory otherwise Prequalification application shall be rejected straightaway.
- 7- No dual offer is accepted. In case of dual offer, Application will be rejected.
- 8- Only Prequalified Firms will be eligible to submit the Technical and Financial Proposals for further evaluation.
- 9- Procurements shall be governed under Pakistan Public Procurement Rules 2004.
