

- •National Vocational and Technical Training Commission (NAVTTC), Government of Pakistan, invites the "Request for Proposals (RFP)" from potential TRAINING PARTNERS (Institute / University / Entity / Company / Joint Venture / Consortium / Industry / Trust etc) of Public or Private Sector to run NAVTTC funded short-term High-End / Industrial and Conventional skill development courses under program titled; "*Prime Minister's Youth Skill Development*." These potential training partners will be required to equip youth with demand driven income generating skills, leading to employment and self-employment. The Quality based selection criteria as provided in PC-I, approved by the CDWP of Planning Commission will be used for scrutiny of Training partners for this highly specialized assignment. The details are available in the bidding document also available on NAVTTC website.
- •An applicant Training partner must be registered/ affiliated/ accredited with relevant Government authority / Law / international agencies and must have *Biometric Attendance Machines and Automated Attendance Management System* facility to be further verified / synchronized with authentic data base services.
- •An applicant university must be chartered and established through a legislative act of respective government and approved / recognized by the Higher Education Commission (HEC), Pakistan. For an institute, it must be registered or affiliated with NAVTTC or respective Provincial Technical Education & Vocational Training Authority (TEVTA), Board of Technical Education (BTE), Trade Testing Board (TTB) or a HEC recognized University. Whereas, an applicant enterprise or industrial unit must be registered under Industrial Act or have the membership with local Chamber of Commerce & Industries and have an Industrial Training Unit for training activities.
- •Detailed requirements for potential training partners, training proposal and the application forms are available on NAVTTC website (www.navttc.gov.pk). The potential applicant training partners are mandatorily required to apply on NAVTTC's online Project Management System (PMS) link: https://nsis.navttc.gov.pk/ w.e.f. 20th September 2023 and by no later than 5th October 2023 (2400 Hrs).
- •Hardcopies of (online filled-in) form along with supporting documents should reach concerned NAVTTC Regional Office (given below) by no later than 07-10-2023 (3:00 PM). The bids shall be opened on 07-10-2023 (5:00 PM). Qualifying Training partners will be informed formally.
- •The process shall be governed under the applicable Rules and NAVTTC reserves the rights to reject any application at any time prior to the acceptance, for any reason, including inter alia unsatisfactory past record; unimpressive training proposals; limited post-training employment / placement prospects; not supported with requisite documents; etc.
